#### **Funding**

**1. The Grousemount Wind Farm Community Fund 2021**, is now open for applications. Community groups within the area of benefit (10Km) of the <u>Grousemount Wind Farm</u>, are encouraged to apply and we would appreciate if you can forward this notification to the relevant contacts on your database.

The closing date for applications is **Wednesday 10th November 2021.** Applications can be made via our website <u>Link</u>

A total Fund value of €145,605 is available to community and voluntary organisations for projects which are based within Grousemount Wind Farm's area of benefit. A maximum of one application can be submitted from each group / organisation per annum.

The Fund supports projects / activities which clearly benefit at least one of the following categories:

- i. Education and skills
- ii. Health, safety and wellbeing
- iii. Environment and habitat conservation
- iv. Energy efficiency and sustainability
- v. Culture and heritage
- vi. Recreation, sport and social inclusion

2. <u>The Community Foundation for Ireland's Covid-19 fund is open for applications</u>. The aim of this fund is to ensure Ireland recovers better than the pre-pandemic status quo. Isolation and the impact on health and wellbeing is affecting people of all ages, so through the Overcoming Isolation grant round The Community Foundation will support social prescribing initiatives in outdoor spaces and online. This will encourage peer support, a sense of community and improved mental wellbeing.

Grants of up to €3,000 will be available for community development organisations for projects that encourage communities to overcome the isolation of the last 18 months through programmes, and developing online platforms and outdoor spaces. The deadline for applications is 4.30pm Thursday 7th October.

### 3. Phase 2 of the Community Development Initiative is closing at 4pm on Friday, 17th September.

This scheme is operated in association with the three Local Community Development Committees (LCDCs) and is a  $\in$ 3.5M fund in total which Cork County Council has been putting its own funds aside on a yearly basis since 2016. Phase 2 will see the release of  $\in$ 750k. The Cork County Community Development Intiative is in co-operation with the 6 Local Development Companies who are who are operating the LEADER Programme, i.e. Avondhu/Blackwater Partnership CLG, Ballyhoura Development CLG, IRD Duhallow CLG, SECAD Partnership CLG, Udarás na Gaeltachta and Comhar na nOileán Teo.

The fund is open to all community groups to improve & enhance their facilities with grants between €1,000 and €25,000 being available to support capital projects.

#### **Training**

**1. CIT are running a free course on Rural Femmes**. Following research in 2020 (survey, focus groups, expert consultation), we have been preparing a novel curriculum to meet the needs of rural women.

The curriculum seeks to fulfill two main goals:

- Develop rural women's basic transversal skills (digital, entrepreneurial, interpersonal, etc.) and
- Address specific technical needs for each activity sector (such as rural companies, sustainable farming, tourism, etc.)

The first session will take place on Sunday, October 3rd with the final session in the first or second week of December. The course will be delivered online on Sunday, Monday, and Tuesday evenings from 6 - 7pm and recordings will be available for those unable to attend some sessions. Networking and connecting with other rural women will be encouraged in group exercises and we have a platform for participants to engage with each other between classes.

**2. CIT are running a free course for New Skills for New Artists**. Following the success of the New Skills for New Artists (NS4NA) pilot course earlier this year, we are delighted to announce a second course from October to December. The course will help you identify and develop a business idea related to your music practice with 3 modules integrating your business, technology, and marketing considerations to help you make your ideas more likely to succeed.

The **free** course will be a blended experience with 1 live class in MTU's Cork School of Music in Cork City centre and 1 online class which will be linked with participating groups in Belgium and Spain.

The course will consist of 3 modules:

- Entrepreneurial and business approaches to musical idea creation, assessment, development, and management;
- Technology, home recording, lighting, audio-visual, streaming, creative uses of technology and
- Social media and marketing including branding, tools and measuring effectiveness.

The three modules will guide you to establishing a business plan for your project; the technological knowledge you will need to implement it and a strategy to reach and grow your audience.

**3. Disability Federation of Ireland** invite you to join us for a Free online Training which will focus on helping people with disabilities to use the UN CRPD as an advocacy tool. The training will focus on helping people with disabilities to use the UN Convention on the Rights of Persons with Disabilities as an advocacy tool. To accomplish this, the training will also use the UN CRPD to demonstrate advocacy and group skills, such as how to approach public officials, and how to decide on an approach and a goal as a group. **4.** The NUI Certificate in Youth Arts is developed and delivered in partnership by Maynooth University and the National Youth Council of Ireland. It is a part-time programme of study (November 2021 – June 2022) in youth arts practice with focus on the emerging field of STEAM (Science, Technology, Engineering, Art and Maths) in Youth Work. This exciting level 7 certificate commences in November 2021 and runs until July 2022. The usual fee for this programme is €1,250. The course is heavily subsidised this year, so as a participant you will pay just €400. Applications are open until September 22nd. Link

5. Minister for Rural and Community Development, Heather Humphreys TD, today announced a new €500,000 initiative designed to raise awareness of the positive role played by Social Enterprises. The Awareness Raising Initiative for Social Enterprise (ARISE) Scheme 2021 will provide grants to Social Enterprises to promote their role in communities across the country. The Fund is another example of how Our Rural Future – the Government's five year rural development strategy – is making a positive impact in rural towns and villages. Link

**6. BirdWatch Ireland is rolling out a** project called Birds Connect. This is a new social inclusion / environment project that some of the members of the Cork County PPN might be interested in participating in.

BirdWatch Ireland receive grant funding from the Community Foundation of Ireland for Birds Connect. The project's focus is connecting people and birds through citizen science, outreach and training. We are particularly interested in exploring innovative ways to improve access and participation in bird projects for people with disabilities, new communities and minority groups. (I've attached the article covering the scope).

As part of this project we have produced a laminated bird identification guide to be distributed to Direct Provision Centres and Nursing Homes. The guide has 50 of our most common Irish birds with illustrations and the names translated into Irish, Arabic and French. This is now printed and it folds up to a quarter of the size. We will supply physical copies of this guide to Direct Provision Centres and Nursing Homes.

We are looking at building connections with the residents of these institutions through a bird nest box project. We are hoping to work with local men's sheds and community groups to build and install nest boxes in Direct Provision Centres and Nursing Homes. The majority of the boxes will be tit or robin-style, as these offer the best take-up rates - but there might be scope for other designs if the right location presents itself. We can provide diagrams of suitable nest boxes.

Joe O'Brien TD Minster of State with responsibility for Community Development and Charities, today (14th September), launched a new National Pilot Community Volunteers Programme in partnership with Volunteer Ireland and Volunteer Centres, supported by Local Authorities. This exciting new volunteering initiative is a government led, nationally formulated programme for the whole of Ireland which will be adapted to suit local needs and build resilience in our communities. It offers a new way to bridge the gap between communities that need support and the people who want to help. It gives people the opportunity to get involved in local events and festivals while also supporting more urgent needs that arise unexpectedly, like the community response to COVID-19. The programme will help organisations respond effectively to needs in our communities by allowing them to engage enthusiastic, trained, local Community Volunteers through their local Volunteer Centres. The programme is funded by the Department of Rural and Community Development and coordinated by Volunteer Ireland and the network of Volunteer Centres, with support from their Local Authority, in each area. 10. Minister for Rural and Community Development, Heather Humphreys TD, has today announced €1.2 million in funding to support recreation facilities and outdoor tourism in forest parks and other Coillte sites.

The investment includes the upgrades of pathways, trails, access roads, boardwalks, carparks and toilet facilities at 33 Coillte sites nationwide. This additional funding means that the Department of Rural and Community Development will be investing  $\in$ 3.2 million in total in outdoor recreation facilities at Coillte sites this year.

Over 18 million individual visits are made to Coillte forests every year with the visitor numbers increasing by 40% during the Pandemic, according to a report published by the Minister today. Link

## 11. Minister for Rural and Community Development, Heather Humphreys TD, today announced €810,000 in funding to support 25 projects under the 2021 CLÁR Programme.

The funding will support local groups in developing community and sensory gardens, outdoor spaces and allotments.

In practical terms, communities will receive funding for the likes of raised flower beds, wildflower gardens, sensory planting, polytunnels, outdoor equipment, picnic tables and shelters. All projects must adhere to the Leave No Trace principles.

The 2021 CLÁR Programme is a key part of the Government's five-year rural development strategy, Our Rural Future.

This year alone, the scheme has delivered over  $\in$ 5.7 million for projects across the country. Link

12. Cork Bike Week 2021 is about to kick-off with events commencing this Sunday (12th September) and running until Saturday, September 18th. As in previous years, Cork County Council has again collaborated with Cork City Council in organising Bike Week 2021.

This year, there are in excess of **170 events** planned across the week.
