09. Deposit Return Scheme is a collection system for used drinks container packaging which incentivises customers to return their empties for recycling or reuse so as to prevent these valuable resources from being discarded. The scheme will also help reduce litter, boost the

recycling sector by collecting high quality materials, support jobs, and assist Ireland in meeting EU targets. As part of Ireland's efforts to promote a wider circular economy, the Minister for Environment, Climate and Communications signed the Separate Collections (Deposit Return Scheme) Regulations 2021 last November and the scheme is due to come into effect in the next

year or so. A deposit will be placed on every metal beverage can and PET plastic bottle (up to 3 litres) and this deposit will be refunded to the customer on each container they return. The 'Return for Change' campaign is working to increase public awareness about what a Deposit Return Scheme is and how to use it. We are looking for your help with this and hoping that your organisation will become part of the awareness campaign. Link 10. The Community Buddy team invites all community and residents groups to join our online training programme. This training is free of charge to all community and residents groups. Link

11. The Minister for Health Stephen Donnelly today launched the National Patient Safety Incidents

The survey, which is being co-ordinated by the Department of Health, is the first part of a research process commissioned by the Independent Patient Safety Council to gather information on culture and values regarding the management of patient safety incidents in our health and social care

services. Patients, service users, family, advocacy providers, healthcare staff and members of the public are invited to take part in the survey to share their views and experiences. Link

12. Cycle Against Suicide is running a Community Buddy programme which is available free of charge to all community groups. This programme trains individuals in communities how to have a structured but supportive conversation in a safe and non-judgemental space. It allows an individual to discuss how they are coping or not coping, and working together, the individual working with the Buddy discuss (co-produce) ways of moving forward to overcome the challenges. During our Community Buddy training, participants will be educated on how stress and mental health problems can affect individuals. They will be instructed in the skills of active listening. They will be trained in the use of a structured interview schedule to ascertain whether individuals might be experiencing significant levels of distress and how to practically manage distressed individuals. Furthermore, they will be trained to mentor individuals to take positive resilience enhancing actions,

such as positive coping. They will be trained on how to recognise more complex symptoms requiring professional interventions. They will develop skills based on the principal of motivational mentoring to encourage individuals to speak with a healthcare professional where necessary.
