The Wheel is delighted to announce that applications for funding are now open under the <u>Training Links programme</u>. Training Networks are invited to apply for grants ranging from €10,000.00 to €50,000.00.

In our biggest round yet, there is a total fund of €575,000.00 available, and applications are welcome from new, existing, previously funded networks who have completed their programme or previously unsuccessful networks.

Applications remain open until 5pm on Friday, 7 Feb 2025.

What is Training Links? Training Links is a funding programme that supports community and voluntary organisations to form Training Networks – groups of a minimum of ten organisations who come together to undertake training that they may not have the opportunity to do individually.

Who can apply? Applications are welcome from community and voluntary organisations based in the Republic of Ireland. To apply, organisations must come together and form a Training Network with a minimum of 10 members.

What is a Training Network? A Training Network is a group of independently run and governed community and voluntary sector organisations who decide to



come together as a group to undertake training that they may not be able to do individually. The term 'community and voluntary' in this instance includes registered charities, social enterprises, independently run nonprofit organisations who are not charities, and incorporated entities.

### What type of training is supported under Training Links?

There are a range of priority training areas covered under Training Links:

- Digital transformation
- Enhance leadership
- Green transition
- Develop new business models
- Achieve high-quality, innovative and responsive workplaces and services
- Address current sector priorities.

What is the Breaking Barriers Fund?

#### **Fund Overview**

Rethink Ireland is partnering with the State Street Foundation, and the Department of Rural and Community Development on the **three-year Breaking Barriers Fund** to support projects or organisations that are working towards Equity in both education and the workplace in Ireland. The fund will support access-to-workplace initiatives, sustaining employment and educational initiatives, in support of the fact that educational attainment leads to better employment opportunities.

The **Breaking Barriers Fund** aims to support awardees that **tackle discrimination and inequality in the Irish labour market and education system**. The fund will achieve this through investments in innovative projects offering tailored solutions combating discrimination and inequality in the Irish labour market or education system with outcomes including (but not limited to); **sustainable jobs, work placements & internships as well as training and education**. The ultimate goal of the fund is to find and back change-making projects that support beneficiaries from the minority communities we have identified into sustainable employment, work placements, education or internships while also tackling discrimination, prejudice and inequality.

The fund will focus on projects which rise to the challenges captured in the following themes:

- 1. Addressing Discrimination and Inequality: This includes tackling labour market discrimination and barriers to employment related to race, ethnicity, and nationality.
- 2. **Increasing Participation and Access**: The fund aims to increase the participation of minority and disadvantaged groups in the labour market and



facilitate better access to higher education, further education, and apprenticeships for those who face barriers (i.e through tailored employability programmes, holistic skills development courses, bespoke employment supports).

- 3. **Eliminate Barriers**: This involves reducing both structural and practical barriers to employment, work placements, and educational opportunities for people/groups who face these barriers.
- 4. **Supporting Career Development and Skills Growth**: The fund supports the career development and personal skills growth of employees/future employees who are under-represented at senior levels.
- 5. **Systems Change Approach-Empowerment of Marginalised Communities**: The fund aims to empower leaders from marginalised and disadvantaged communities to self-advocate and champion their cause, strengthening networks and partnerships to challenge discriminatory practices and support systemic reforms that enhance access to decent work or education for the most marginalised communities.

#### **Target Groups:**

This fund will work with organisations that directly support beneficiaries most affected by discrimination and inequality of access, in both education and employment, from the following population groups:

- Travellers/Roma (minority community)
- Migrant communities including refugees & undocumented migrants (minority community)
- Ethnic minorities (including people of colour )
- Minority religious and cultural groups (minority community)
- People seeking asylum (the majority of whom are living in direct provision)

#### LAWPRO Catchment Support Fund 2025

Press Release: Funding available nationwide to support communities delivering projects to improve water quality - Local Authority Water Programme

The Catchment Support Fund for 2025 is now open for applications and the fund aims to build the capacity of non-governmental organisations working in the area of water quality by providing funding towards their core costs. I have attached the guidance for you to look through.

Organisations who receive operational funding from Government Departments (e.g. Tidy Towns Groups, Group Water Schemes, etc.) <u>are not eligible</u> where grant aid funding is available for eligible costs from other funding sources. Groups that receive membership fees may not be eligible for all elements of Stream 1 funding i.e., insurance, audited accounts, etc.

The fund is divided into two streams which cover the following:

#### Stream 1

- Statutory and/or legal responsibilities
- Training and other capacity building costs
- Auditing/accounting fees
- Insurance associated with catchment management
- Website annual support cost
- Organisation promotional materials
- Group development activities (e.g., Development of group plan/strategy; group management; governance assistance).

#### Stream 2

- Funding towards your organisation's core costs. Core costs include staff salaries, rent, rates.
- Costs to help your organisation be more resilient in the future, for example, adapting business plans, corporate governance improvements, risk management reviews and piloting new ways of working.
- Training and skills development costs.
- Costs associated with the hiring of new or contract staff to help deliver the organisations Work Programme. A clear job description for the post must be provided with your application.

#### The Heritage Council: Organisations Support Fund

The Heritage Organisations Support Fund aims to build the capacity of nongovernmental organisations working in the heritage sector in Ireland by providing funding towards their core costs.

Recognising the critical role heritage projects play in addressing climate change and biodiversity loss, the Heritage Organisations Support Fund 2025 prioritises support for projects that **demonstrate environmentally sustainable practices**.

This funding will provide support to:



- develop and strengthen the skills, processes, and resources that heritage organisations need to survive, adapt, and thrive.
- heritage organisations who play a key role in the heritage infrastructure of Ireland and to help achieve national policy and plans.

The **National Parks and Wildlife Service (NPWS)** Peatlands and Natura Community Engagement Scheme 2025

A fund of up to €600,000 is being made available to support community-led projects as part of the Peatlands and Natura Community Engagement Scheme 2025. The Peatlands and Natura Community Engagement Scheme (PNCES) operated by the National Parks and Wildlife Service, is now open for applications for 2025 with a closing date of 24 January 2025.

The Scheme aims to encourage communities, local organisations and other interested parties to become involved in the <u>enhancement of their natural surrounding areas and</u> <u>to raise awareness</u>. Applications are welcomed across a diverse range of initiatives with community benefit from events, education programmes, promotions, publications, exhibitions, development of conservation management plans, public amenity and recreational measures, maintenance measures that support conservation measures, monitoring or surveying work to inform of restoration/conservation projects, invasive species and fire control measures, anti-littering initiatives to local environmental improvements in the area of the designated sites and other peatland areas.

The PPN is responsible for the election of environment, social inclusion and the community sectors Reps onto SPCs. To find out more about the scheme, you can read the <u>STRATEGIC POLICY COMMITTEE SCHEME 2024- 2029</u> on the Cork County Council's website.

It is the task of the Strategic Policy Committees (SPCs), as committees of the council, to advise and assist the council in the formulation, development and review of policy. They have no remit in relation to routine operational matters regarding the delivery of services. The SPC system is intended to give councillors and relevant sectoral interests an opportunity for full involvement in the policy making process from the early stages.

#### Local Community Development Committees (LCDCs) North, South and West

The Local Community Development Committees (LCDCs) were set up as part of the Local Government Reform Act 2014 in each Local Authority area. The aim of LCDCs is to enhance the strategic planning and coordination of local and community development activity. LCDCs comprise public and private sector members, including Local Authority members and officials, state agencies, and private sector local and community development representatives.

#### **Functions**

The key functions of the LCDCs are as follows:

- Prepare the community elements of a 6 year Local Economic & Community Plan (LECP) (pdf)
- Implement, or arrange to implement, the community elements of the LECP
- Monitor implementation of the LECP
- Coordinate, manage and oversee the implementation of local & community development programmes, for example: SICAP and the Rural Development Programme
- Improve coordination and reduce duplication of efforts
- Consider a draft of the economic elements of the LECP Plan and adopt a statement in this regard
- Prepare an annual report

Cork County Council has established three LCDCs, aligned with the local government administrative boundaries of North, South and West Cork. Each LCDC can have between seventeen and nineteen members. There must be a mix of both public sector and private sector representatives, with the majority of the members coming from the private sector.

### CHRISTMAS ROAD SAFETY CAMPAIGN LAUNCHED



The Road Safety Authority is urging drivers nationwide to stay safe and sober this festive season as new data from the Medical Bureau of Road Safety (MBRS) show concerningly high levels of alcohol and other drugs in driver toxicology testing.

With December bringing holiday celebrations into full swing, the RSA, An Garda Síochána and the MBRS are urging motorists to stay drug and alcohol free to prevent collisions and protect all road users this Christmas.

During the month of December 2023, 14 people lost their lives on Irish roads and 124 were seriously injured. So far this year, there have been 165 people killed on Irish roads. The RSA, An Garda Síochána, and MBRS are calling on everyone to act responsibly to prevent further tragedies on Irish roads. Each life lost is a family left grieving and forever shattered.

RSA behaviour and attitudes research, conducted in November 2024, found that 11% of motorists admitted to driving after consuming any alcoholic drink in the past 12 months. Meanwhile, 25% of motorists said: "it is acceptable to drive short distances in your local area after consuming one alcoholic drink".

#### An Garda Síochána

To date in 2024, An Garda Síochána have carried out over 100,000 checkpoints, averaging 300 checkpoints per day.

- Almost 50% of checkpoints are Mandatory Intoxicant checkpoints (MIT), established under statutory orders, an increase of 16% over the same period in 2023.
- Breath tests (alcohol) have increased by 26% over 2023.
- Oral Fluid Tests (Drugs) have increased by 57% over 2023.
- To end November 2024, over 7000 drivers have been arrested on suspicion of Driving under the influence of Alcohol or Drugs, over 1 driver every hour, every day.
- 56% of arrests are alcohol related. 44% drugs related. The number of drug driving detections is up 11% on 2023.





Those that take drugs or have alcohol before getting into the car to drive are playing roulette with their own life and the lives of other road users.





### Stay safe online this Christmas! - Upgrade Scam targeting mobile phone users

**CURRENT THREAT** 

Cork County Council's ICT Security have been made aware of an ongoing scam targeting mobile phone users. Scammers are impersonating mobile phone provider representatives and using deceptive tactics to gain access to your account in order to steal valuable mobile devices. Here is how the scam works and how to protect yourself.

### <u>How the Scam Works</u>

- 1. **Cold Call**: The scammer calls you, claiming to be from a mobile provider, offering an upgrade on your mobile phone contract or some other offer. At this stage they try to confuse the victim by being unclear about why they are ringing.
- 2. Account Access: While on the call, the scammer uses the "Forgot Password" option on the mobile providers website. This triggers a verification code to be sent to your phone.
- 3. **Code Request**: The scammer asks you to read out the verification code, claiming it's necessary to process your upgrade.
- 4. **Account Hacked**: Once the scammer has the code, they reset your online account password and gain full access.
- 5. Fraudulent Order: The scammer orders a high-value phone to be delivered to your address.
- 6. **Second Call**: After the phone arrives, the scammer contacts you again. When you express confusion or refusal, they offer to "resolve the issue" by collecting the phone and processing a refund.
- 7. **Collection**: The scammer arranges for the phone to be collected, leaving you without the device and potentially liable for the cost

#### <u>How to Protect Yourself</u>

- **Never Share Verification Codes**: No legitimate company will never ask for a one-time code or password over the phone
- Verify the Caller: If someone claims to be from your mobile provider, hang up and call your provider directly using the official customer service number
- Monitor your account: Regularly check your account for unauthorised activity or changes
- Use strong, Unique passwords: Avoid using easily guessed passwords and enable additional security features, such as two factor authentication, if available

ALWAYS REMEMBER TO ...



IT Security is critical both in your work and home life and these types of attacks may increase over time so please err on the side of caution and be vigilant at all times.

Always Remember to...

- Be SUSPICIOUS of e-mails that ask for personal information
- Do NOT click on links in an e-mail / text that you are suspicious of
- NEVER open attachments or click links in suspicious e-mails / texts
- NEVER send your password or personal information in response to any e-mail, even if it does not seem suspicious
