Council's Circular Economy Fund 2025
Open for Applications**



Cork County Council has launched a second round of its Circular Economy Fund, with the aim of empowering local action to reduce waste. The fund aims to support communities to move away from the traditional linear 'take-make-use-dispose' model towards more circular living where resources are reused or recycled.

This year, schools, community groups, sports clubs, and festivals are invited to submit proposals aimed at minimising single use plastics. These plastic materials pose a significant threat to our environment, contributing to pollution in our oceans and harming wildlife.

With an increasing demand from the public to reduce single use plastics and a desire from communities to act, the fund will support projects such as the installation of temporary or permanent water refill stations or reusable cup or container schemes in schools, community buildings, sports clubs and at festivals. The Council hopes to build

on the success of recent years, which has seen over 40 water refill stations installed in schools and community buildings as well as numerous pilot mobile hydration stations at events across the county.

Mayor of the County of Cork, Cllr. Joe Carroll welcomed the return of the fund saying, “Reducing single use plastics is an important step in our journey to cutting waste, conserving resources, and protecting our environment. Cork County Council’s Circular Economy Fund is designed to support communities in their transition to more sustainable practices. We have already seen many successful projects from community groups in the first year of this fund and I look forward to seeing many more this year.”

Applications for the Circular Economy Fund are now open and will be accepted online until Friday the 21st of February at 5:00pm. Eligible applicants in the Cork County Council administrative area include schools, community groups, sports clubs, festivals and events. Commercial, for-profit bodies are not eligible. Only applications addressing the single use plastics theme will be assessed in the 2025 Fund, the ambition is to focus on a wider range of circular themes in future years.

EirGrid announces opening of next phase of €2.4m community benefit fund

EirGrid, the operator and developer of Ireland's electricity grid has announced the opening of the next phase of community benefit sharing for the Celtic Interconnector project. Applications for the second phase of the €2.4 million fund are now being welcomed, with €841,013 in funding available to eligible communities and voluntary groups.

The Celtic Interconnector Community Benefit Fund was established by EirGrid to recognise the importance of local communities who facilitate this critical development of the electricity grid and will benefit groups and projects in the east Cork project area.

The Celtic Interconnector, a 575km subsea link between Ireland and France, will enable the movement of electricity between the two countries, making our electricity supply more secure. The community benefit fund is open to community groups and not-for-profit organisations who can demonstrate benefits to communities from the services, programmes or facilities they provide in the project area, under three streams of funding: community, sustainability and biodiversity.

Funding of €240,000 will be available for community projects, €240,000 for sustainability projects and €361,013 for biodiversity projects, with a €121,013 underspend carried over from the first phase of the fund under the biodiversity stream.

The first phase of the Celtic Interconnector Community Benefit Fund saw 29 community groups receive a total of €838,987, with funding supporting a wide range of projects, from the funding of an electric vehicle community bus, the funding of LED floodlights for Youghal Rugby Football Club, to supporting the development of a school's sensory garden.

Speaking about the fund opening, Sinead Dooley, Head of Public Engagement, EirGrid said: *"We're delighted to open the next phase of this fund and build on the incredible projects already completed. These initiatives demonstrate the power of collaboration and show how targeted support can make a real difference. We strongly encourage communities to apply, particularly for projects with a biodiversity focus."*

Dooley added, *"This fund shows EirGrid's commitment to supporting local communities as they further environmental sustainability and civic initiatives. We want to thank all the communities*

in east Cork who have collaborated with us so far as we work to deliver this strategic energy project and we look forward to seeing what can be achieved through this latest phase of funding.”

RISE COMMUNITY FUND TO AWARD CASH GRANTS THROUGHOUT FEBRUARY

The RISE Community Fund has announced plans to award new cash grants to small businesses, farms, social enterprises, schools, charities and community groups, with funding available to those who can demonstrate innovative plans to use technology to scale the positive impact of their work and benefit the local community.

Applications for the cash grants open today and close on 28 February 2025. Grants of up to €1000 will be available to successful applicants across the country.

Supported by National Broadband Ireland (NBI), the company responsible for delivering the Irish Government's National Broadband Plan, as well as other corporate partners including KN Circet, KPMG, Test Triangle, DreamDev Technologies and TLI Group, the RISE Community Fund has travelled the breadth of the country in recent years to provide a cash injection for community organisations thinking creatively about how they can use technology.

Previous grant recipients include farm owners who are using technologies to improve the productivity and environmental impact of their practice; community groups upskilling local residents in new technologies; schools introducing children to coding and cutting edge advancements; and small businesses using technology to grow their operations nationally and internationally.

The application process is incredibly quick and easy, and successful applicants will be notified in March, with money following in quick succession.

2025 CHILDMINDING DEVELOPMENT GRANT OPENS FOR APPLICATIONS

The Childminding Development Grant provides up to €1,000 to assist both registered and unregistered childminders who are providing a childminding service in their own homes.

Applications for the 2025 Childminding Development Grant open on Tuesday, 4 February and close on Friday, 4 April.

The grant aims to support childminders to enhance quality and safety in their service through the purchase of toys, childcare equipment, safety equipment, equipment to support inclusion and Science, Technology, Engineering, Arts, and Maths (STEAM) education, as well as IT equipment to assist childminders to engage with training and registration processes.

The grant scheme is open to all childminders, including those who are planning to open a childminding business during 2025. 75% of the grant is paid in advance to help childminders with the upfront costs of purchasing equipment.

Making today's announcement, Norma Foley, Minister for Children, Disability and Equality said:

"I am delighted to announce the launch of the 2025 Childminding Development Grant as one of the first actions in my term of office as Minister.

"Childminders play an essential part in the provision of childcare in all parts of the country, and I am fully committed to recognizing and supporting their important role, and to following through on the National Action Plan for Childminding 2021-2028.

"I encourage childminders to avail of this funding opportunity, whether they are already registered or would like support in advance of registration over the next couple of years.

"The Childminding Development Grant provides funding for quality and safety equipment and can also be used to contribute to IT equipment."

The total budget of €500,000 reflects the high demand for the grant in previous years. It also reflects the Government's commitment to support childminders to prepare for registration with Tusla. In line with the National Action Plan for Childminding 2021-2028, regulations written specifically for childminders came into effect for the first time

in September 2024, making it possible for all childminders to register with Tusla and take part in the National Childcare Scheme (NCS).

Those childminders who were previously exempt from regulation have a three-year transition period until 2027 during which they are now able to register with Tusla but are not yet required to do so.

COMMUNITY HERITAGE GRANT SCHEME

An annual grant scheme for community groups and not-for-profit non-governmental organisations around the country for heritage projects.

This scheme is intended to enable communities and heritage non-governmental organisations (NGOs) to continue their work on existing projects or to start new initiatives.

A broad range of project types are eligible for funding under the scheme including:

- Workshops and training events that promote good heritage practice, in particular, we are interested in traditional building skills, craft skills, graveyard recording and biodiversity training.
- Development of Digital Heritage Resources including digitisation, online exhibitions, oral history recordings, podcasts, and films. You need to make sure that the digital outputs you create with grant funding are **available, open, and accessible**.
- Conservation surveys, reports, plans, and audits that will inform the future management of buildings and monuments, habitats, collections, or objects.
- Conservation works to buildings, monuments, habitats, collections, or objects. Conservation works must include an assessment of potential impacts on biodiversity and climate and outline measures to ensure positive outcomes. For example, habitat restoration, sustainable management of invasive species, or improving energy efficiency in heritage buildings.
- Purchase of specialised equipment or items that support conservation or improve access to heritage.

Who can apply?

The scheme is open to:

- Voluntary and community groups for example parish councils, tidy Towns groups, local action groups etc
- Non-governmental organisations (NGOs) including not for profit trusts

- Museum Standards Programme for Ireland (MSPI) participants (non governmental organisations only)
- Adopt a Monument Programme participants

The applicant group must have a current bank/credit union account in their name.

The Scheme is **not open** to

- Private companies
- Individuals
- Public bodies or organisations controlled either directly or indirectly by any state or other body.

BRIGHTER FUTURES FUND 2025 – 2028

What is the Brighter Futures Fund?

The Brighter Futures Fund is a three-year fund aimed at improving mental health and wellbeing for marginalised groups in Ireland. We invite applications from projects and organisations that proactively identify mental health challenges within marginalised communities, enabling early intervention that can prevent the escalation of these issues. This fund is created by Rethink Ireland in partnership with an anonymous donor and the Department of Rural and Community Development via the Dormant Accounts Fund.

Brighter Futures Fund will support organisations representing a diverse range of vulnerable groups in Ireland dedicated to addressing mental health and wellbeing disparities. These may include groups such as LGBTQI+, Traveller, Roma, migrant, or refugee communities and other vulnerable groups.

Whilst this fund aims to support projects and organisations focusing on early intervention, we understand that such a timely intervention is not always possible. Therefore, the projects/organisations who apply for the Brighter Futures Fund can be working across the full spectrum of mental health initiatives, including early interventions, wellbeing and resilience programmes, confidence-building supports, and/or initiatives for fighting depression/social anxiety/loneliness/stress etc. This is not an exhaustive list. We want to back organisations who will equip marginalised communities with the skills they need to improve and maintain their mental health and wellbeing over time.

The Fund offers a package of cash grants and non-financial supports to the value of €1.9 million for up to six projects to help them expand and increase their social impact.

This includes:

- Up to six awards of up to €285,000 (up to €95,000 per year for three years)
- The non-financial supports include:
 - a place on Rethink Ireland's Accelerator Programme
 - bespoke business and capacity-building supports designed in consultation with successful projects on topics such as strategic planning, maximising your impact, communications, storytelling and fundraising
- Access to Rethink Ireland's networks

** The Rethink Ireland Board will decide how much money to award, which may be less than the amount requested. The final award amount will depend on how many organisations are selected.*

You can apply to the Brighter Futures Fund via the **online portal** from Monday, 27 January 2025 to Monday, 24 March 2025.

HUMANITARIAN ASSISTANCE SCHEME

What the Humanitarian Assistance Scheme

is:

The Humanitarian Assistance Scheme provides income tested financial assistance to households affected by a severe weather event. It is administered by the Community Welfare Service.

The scheme aims to lighten the hardship rather than provide full compensation for damage.

The scheme may cover:

- emergency support payments, such as food, clothing and personal items
- damage to your home and its essential contents, such as carpets, flooring, furniture, household appliances and bedding
- structural damage

The scheme does not cover:

- losses covered by an insurance policy
- loss of items deemed to be inessential or luxury items
- commercial, agricultural or business losses
- structural loss or damage to rented accommodation
- any additional properties that are not occupied and lived in as the primary residence
- repair or replacement of motor vehicles

In dealing with emergency events the department generally adopts a three-stage approach as follows:

- Stage 1 provides emergency support payments (food/clothing/personal items) in the immediate aftermath of the event

- Stage 2 involves the replacement of white goods, basic furniture items and other essential household items
- Stage 3 is to identify what longer term financial support is required, including plastering, dry-lining, relaying of floors, electrical re-wiring and painting

Income limits for the scheme are:

- €50,000 for a single person
- €90,000 for a couple
- €15,000 per dependent child

Reduced or tapered level of support may be provided in cases where your household income is above the limits.

The 2025 ESB Wind Farm Community Funds are now open for applications until **March 7th 2025**. Please feel free to share this with any relevant groups in your database.

The fund is available to community and voluntary groups, non-profit groups or organisations with a charitable status. The Wind Farm Community Funds will prioritise projects and initiatives that support and benefit the areas surrounding ESB wholly owned and co-owned wind farms, in the following categories:

- Education and skills
- Health, safety and wellbeing
- Environment and habitat conservation
- Energy efficiency and sustainability
- Culture and heritage
- Recreation, sport and social inclusion
- Tourism (Raheenleagh & Castlepook only)

Getting started on your project ideas early will greatly assist with your application, as a well-developed project is key to a successful outcome.

It is essential to note that applications from groups that do not submit required documentation with the application form e.g. planning permission, planning exemption, confirmation that you have liaised with your local authority or owner permission, may not proceed to evaluation.

If you registered for a previous call, you can use the same user name and password to apply to the 2025 fund.
